### 07. ELIGIBILITY OF PARTICIPATION

- 7.1. This tournament is opened to all volleyball players and volleyball enthusiasts in Johor state, in Malaysia or other countries below 12 years old only .  
{ Born on 1997 and after }
- 7.2. Each team must provide **2 Linesmen** throughout the tournament while the game is in progress.
- 7.3. A team is composed of 1 Team Manager, 1 Coach, 1 Assistant Coach and 12 players or 11 players + 1 Libero .
- 7.4. Each player only can be registered to represent one team only

### 08. REGISTRATION & DRAWING OF LOTS ]

- 8.1. Numbers of participating team are limited to :
- 8.1.1. Boy's Category : 12 Teams
- 8.1.2. Girl's Category : 12 Teams
- 8.2. Each team is allowed to register up to 12 players

### 09. COMPETITION REGULATION

- 9.1. In addition to the stated rules and regulation, the current ( FIVB 2009 – 2012 ) rules and regulations are also applied in this tournament.
- 9.2. In case of disagreement in the interpretation of rules, the English text of the rules shall prevail. Any unforeseen incident not covered by the rules shall be dealt with accordingly in the following manners
- 9.3. Any unforeseen incident not covered by the rules shall be decided by the organiser.
- 9.4. All decisions by the organizer are final.

### 10. COMPETITION SYSTEM

- 10.1. All matches shall be played in system "Best of 3". For the deciding set, the match shall be played in the point of 25. ( include Semi -Final & Final )
- 10.2. The competition system shall be played as below:-
- 10.2.1. Less than 12 teams, ( League in Groups)

### 11. CLASSIFICATION SYSTEM

- 11.1. Winning Team : 2 Points  
 Loser Team : 1 Point  
 Technical Disqualification : 0 Point
- 11.2. When there is a tie in points, 2 teams or more teams during the preliminary phase, the following shall be used to determine the order;

$$A = \frac{\text{Total Points won}}{\text{Total Points Lost}} \quad \text{All Matches In The Group}$$

The team with higher ratio of sets will be awarded the higher position in the group.

- 11.3. If there is still a tie in points , the following formula is applied;

$$B = \frac{\text{Total Sets Won}}{\text{Total Sets Lost}} \quad \text{All Matches In The Group}$$

The team with higher ratio of sets will be awarded the higher position in the group.

11.4. If there is still a tie in points , the following formula is applied;

$$C = \frac{\text{Total Sets Won}}{\text{Total Sets Lost}} \times \text{Matches Between The Involved Teams}$$

The team with higher ratio of sets will be awarded the higher position in the group.

11.5. If there is still a ties between 2 teams, the match result between the two teams will be used to determine the position of these two team. The team which had won the match among them will be the winner.

11.6. If there is still a tie among 3 or more teams, the final result will be decided by drawing lots.

### 12. TEAN JERSEY

12.1. All players in the team must wear the team jersey with number from 1 till 18 only. The "Libero" shall wear the different colour jersey.

12.2. Measurement of number area is **15 cm** in center front and **20 cm** at the center back.

12.3. All the Coaches , Assitant Coach and Trainer are required to wear long pants /track pants and sporst shoes during the tournament

### 13. COMPETITION NET HEIGHT

13.1. Boy's Category : 2.10 meter

13.2. Girl's Category : 2.10 meter

### 14. WALKOVER

- 14.1. Each team must be at the court 30 minutes before the start of the match.
- 14.2. Team which was 15 minutes late after the schedule match without a valid reason shall be considered given a walk over to the opponent team.
- 14.3. Team which conceding walk-over to other team shall be considered as withdraw from the competition and shall not be allowed to participate in the subsequent matches. All the results of previous matches shall be forfeited

### 15. REFEREEING

- 15.1. Tournament Refereeing Committee shall engage qualified referee during the whole tournament.

### 16. SANCTION

- 16.1. A player who was ejected from the tournament due to disciplinary behaviour shall be automatically suspended from all subsequent matches pending decision from the Tournament Disciplinary Panel.

### 17. PROTEST

- 17.1. The result of the referee is final. Any protest to the competition rules and regulations shall be referred to the Chairman of Organising committee.
- 17.2. In the occasion where the Organizing Committee Chairman is unable to solve the protest issue, the protest shall be referred to Complaint Committee. The team wishes to make the protest during a match must inform the referee verbally. In this incident, the match is continue playing " Under Protest ". Only the team captain is allowed to make the protest.
- 17.3. All protest must be presented in writing to Panel of Appeal within 30 minutes after the match and be companied with cash deposit of RM 500. The deposit will be forfeited if the protest is not valid.

### 18. PANEL OF APPEAL

- 18.1. Panel of Appeal consists The Chairman of Organising Comitee or the representative who acts as the Head of Panel of Appeal, Head of Referees in the tournament, and 2 team managers who are not from teams involving in the complaint.
- 18.2. The Panel of Jury will meet within 1 hour when receiving of complaint. The result of the panel is final.

3RD PLACING	: 1 Trophy + 12 Medals
4TH PLACING	: 1 Trophy + 12 Medals

- 20.1. The organizer reserves the right to invite any qualified team to participate in this tournament when there is a shortage of team to participate when the deadline of registration is over.
- 20.2. The Organiser reserves the right to decide the result during an unforeseen circumstance in the tournament and the result is final.
- 20.3. The Organizer reserves the right to change any rules and regulations when needed. Any changes of rules and regulations shall be informed as soon as possible or before the start of the first match of the tournament.
- 20.4. Each match shall be commenced according to the scheduled time. However, the organizer reserves the right to change the match sequence and match time when needed. All the changes shall be informed to each Team Manager as soon as possible.
- 20.5. The Organizing Committee and its appointed officials shall not be held responsible for any accident or lost of persona belonging during the tournament.
